### DECISION RECOMMENDATIONS

**That Council:**

1. Consider increasing the membership of the Audit and Risk Assurance Committee to include one additional Independent Member.
2. Subject to (1) above, consider the appointment of Heikki Doyle as Independent Member to the Audit and Risk Assurance Committee for the four year period ending 15<sup>th</sup> October 2022.

#### 1 **PURPOSE OF THE REPORT**

##### 1.1 **Independent Member for the Audit and Risk Assurance Committee**

1.2 At the Council meeting on 4 April 2017, as part of the 2017/18 Governance (Committee and Scrutiny Board Structure) review, it was agreed to appoint a second Independent Member to the Audit and Risk Assurance Committee.

1.3 The position was appointed to by Council at its meeting on 17 July 2018.

- 1.4 In view of the high calibre of applications, approval is now sought from Council to consider increasing the membership of the Audit and Risk Assurance Committee and to appoint a third Independent Member.
- 1.5 Interviews took place on 9 July 2018. The interview panel consisted of the Chair of the Audit and Risk Assurance Committee, the Head of Audit and the Director – Monitoring Officer.
- 1.6 Should Council be minded to increase the membership of the Audit and Risk Assurance to allow an additional Independent Member, approval is sought to the appointment of Heikki Doyle for a four year period ending 15<sup>th</sup> October 2022.

## **2 IMPLICATIONS FOR SANDWELL'S VISION**

- 2.1 The Audit and Risk Assurance Committee contributes to the achievement of Sandwell's vision by examining and reporting on the state of the council's governance, risk management and internal control environment.

## **3 STRATEGIC RESOURCE IMPLICATIONS**

- 3.1 The role of Independent Member is a voluntary position and no annual allowance is paid in respect of this appointment. However, travelling and subsistence expenses are paid at the appropriate rate. The cost of advertising is met from within existing budgets.

## **4 LEGAL AND GOVERNANCE CONSIDERATIONS**

- 4.1 The Audit and Risk Assurance Committee operates to an approved terms of reference, based upon a model from the Chartered Institute of Public Finance and Accountancy.
- 4.2 Local authorities should have regard to section 13 of the Local Government and Housing Act 1989 which relates to the voting rights of non-elected committee members. Where the audit committee is operating as an advisory committee under the 1972 Act, making recommendations rather than policy, then all members of the committee should be able to vote on that recommendation. If the council wishes to delegate decisions to the committee, for example the adoption of the financial statements, then the independent member will not be able to vote on those matters for decision.
